The determination of condition will lead directly into calculations for effective age will be defined and demonstrated on how to extract it from the market. Topics discussed are: USPAP review, cost approach, quality, condition, physical deterioration using effective age, functional obsolescence, external obsolescence and depreciation and effective age extraction.
